Medbuy - GPO—Medical/Surgical/Pharmacy Conversion

- Pharmacy conversions total 30 contracts. Please refer to the spreadsheet for the work in progress on the Microsite. Med-Buy's Krista Logan is the pharmacy contact and is responsible for developing the overall pharmacy transition plan. Krista can be reached at (519) 652-1688 ext 135.
- Medical/Surgical Conversions are continuing, and a schedule for contracts expiring is regularly being updated on the <u>MedBuy</u> <u>website</u>. Contact Nicole Landgraff, our Clinical Contract Specialist, should you have any questions specific to your schedule.
- A highlight from Medbuy's Sept 23rd newsletter (MedWeek) is that Medbuy's Medical Doctor will sit on OHA's panel for Supply Chain Education at their annual conference.

GHX - Data Management Implementation

- The quarterly update from Ormed should be available shortly, this includes support for electronic invoice (810) and contract update (832)transactions.
- Loading of local contracts is progressing well and this will help capture price discrepancies when ordering items that are on contract outside of our GPO's contracts.
- Hospitals with a lower volume of transactions may be taking advantage of TBRHSC's distribution capability to streamline their ordering and this will allow volumes to be captured in the data management at TBRHSC.
- TBRHSC is investigating buying an inventory sales module, in order for their material management system to handle the invoicing and order processing for the distribution of product to some of the area hospitals to enhance data accuracy and bring greater efficiencies.

Collaboration with other Shared Service Organizations

NSC is teaming with Mohawk for an Ophthalmic Lens Initiative. We will be canvassing sites about volumes, types of consumables, custom packs, capital associated (sites to be included are LWDH, WMGH and TBRHSC)



Medical Mart - Distribution Conversion

The implementation is proceeding well and we are continuing to onboard non inventory items from most hospitals for this initiative. Almost all of the sites have returned their surveys and conversions continue by Vendor.

NSC and Medical Mart are meeting to determine the next items to convert. Currently the recommendation is to convert non-stock (catalogue to catalogue) where able. A discussion has taken place with NSC, Medical Mart and the Vendors regarding price discrepancies with Covidien and Bard products. Solution pending.

A reminder about the additional rebate for e-commerce. A few members are still not currently paying Medical Mart invoices by electronic funds transfer but instead by cheque, if NSC can assist in setting this up please contact Emil Engler. In conclusion 3rd and 4th quarter results indicate we will surpass anticipated purchases for years 2-5 of the contract by a significant margin.
